《The Hainan Free Trade Port Law》 of the People's Republic of China was adopted at the 29th Meeting of the Standing Committee of the 13th National Congress of the People's Republic of China on June 10, 2021, and is hereby promulgated and shall come into force on the date of promulgation.

FTP Law – die Freiheiten

The construction and management activities of Hainan Free Trade Port are subject to this law, which provides legal protection and institutional design for Hainan Free Trade Port, including

- trade (Zero Tarif),
- investment (short negative list),
- cross-border capital flow,
- personnel entry and exit (59 Länder Visum-frei f. 30 Tage, easy work-visa),
- free and convenient transportation, and
- secure and orderly flow of data (Facebook, You-Tube etc.)

Hainan Free Trade Port is a special case and the **only region** with a dedicated law – “**The Hainan Free Trade Port Law of the People's Republic of China**” – 中华人民共和国海南自由贸易港法

Hainan FTP has formulated and issued the first batch of supporting regulations, including the

- "Hainan Free Trade Port Optimization Business Environment Regulations",
- "Hainan Free Trade Port Anti Consumption Fraud Regulations",
- "Hainan Free Trade Port Fair Competition Regulations"
- "Hainan Free Trade Port Social Credit Regulations"
